SECTION 4: First aid measures

4.1. Description of first aid measures

If any health problems are manifested or if in doubt, inform a doctor and show him information from this safety data sheet.

If inhaled

Terminate the exposure immediately; move the affected person to fresh air. Beware of the contaminated clothes. Depending on the situation, call the medical rescue service and ensure medical treatment considering the frequent need of further observation for at least 24 hours.

6.3. Methods and material for containment and cleaning up
